PRESIDENT'S MESSAGE

Tom Winslow, Club President

The Catawba Valley Gem and Mineral Club board of directors met on September 28. At that meeting we approved several changes to the Constitution and Bylaws plus a number of other items that we will bring before the membership at the next meeting. The Board approved funds to purchase *Microsoft Office* software (up to \$500) for the treasurer and we also approved funds for a *Catawba Valley Gem and Mineral Club* website (up to \$1000).

It is Time to Begin the Process of Electing Officers and Directors for the 2011 Year

Several people asked about the duties of a different officer and director positions so you will find the job descriptions listed in this newsletter.

Please review the duties of the officers and directors and give strong consideration to participating this year in the leadership of your club. We can only have a strong club if everybody does their part.

OFFICERS AND DIRECTORS

Section 1 - Officers of the Club shall consist of a President, Vice-President, Secretary and Treasurer, all of whom shall be elected.

Section 2 - The Board of Directors of the Club shall consist of the Club Officers, the Show Chairman (or both Co-Chairmen), the Bulletin Editor, and one Member-at-Large all of whom shall be elected, plus the immediate past President. In the event that the immediate past President is no longer a member of the Club, a replacement board member shall be elected from the membership. In the event that any person is elected to more than one position, an additional board member shall be elected from the membership.

Section 3 - The Board of Directors shall act as a steering committee for the Club and, if necessary, make decisions in the best interest of the Club. They shall also approve the disbursement of funds, as limited by Article XII of the club By-Laws.

DUTIES OF OFFICERS AND DIRECTORS

Section 1 - The President shall preside over all meetings of the Club and of the Board of Directors, and shall be an ex-officio member of all committees except the Nominating Committee. The President shall have the privilege of succeeding himself. His tenure shall be limited to two (2) consecutive terms in addition to any partial term of that office he might have served, but shall not limit re-election at a later date.

Section 2 - The Vice-President shall perform the duties of the President in the absence of the President and shall have the added responsibility as Program Committee Chairman. The Vice-President shall have the privilege of succeeding himself. His tenure shall be limited to two (2) consecutive terms in addition to any partial term of that office he might have served, but shall not limit re-election at a later date.

Section 3 - The Secretary shall maintain minutes of meetings of the Club and of the Board of Directors, and handle such correspondence as shall be deemed necessary. The Secretary shall be responsible for publishing and distributing a club roster no later than the March meeting and for distributing an up-to-date roster, Constitution and By-Laws to new members. The Secretary shall be the custodian of all business correspondence, permanent business records (except the Treasurer's records) and the official documents of the Club including: The Articles of Incorporation, By-Laws, etc., and shall present such records to the Directors upon request. The Secretary may succeed himself so long as the Club desires and he is willing to accept the responsibility.

Section 4 - The Treasurer shall collect and periodically account for funds due the Club, make such disbursements as shall be approved by the Directors, Officers or Committee Chairmen responsible for them, and maintain custody of funds retained by the Club. The Treasurer shall prepare and present a financial report of the annual show no later than sixty (60) days following the show. The Treasurer shall be the custodian of all financial records, insurance policies, business licenses, etc., and shall present such records to the Directors upon request. The Treasurer may succeed himself so long as the Club desires and he is willing to accept the responsibility. (Amended 1978, 1983

Section 5 - The Show Chairman shall have responsibility for direction of the annual show. The newly elected Show Chairman shall have the added responsibility of being Vice-Show Chairman until the close of the show following his election. At this time, he takes office as Show Chairman and begins preparation for the next show. The Show Chairman shall present a physical report of the annual show no later than sixty (60) days following the show. This physical report shall include an inventory of all show materials and their storage location. The Show Chairman may succeed himself so long as the Club desires and he is willing to accept the responsibility. (Amended 1983).

Section 6 - The Bulletin Editor shall publish, once each month, a bulletin including, but not limited to: the date and place of the next meeting, information pertaining to the field trips, additions and deletions to the roster, a synopsis of the minutes of the board and club meetings and other information related to the Club and the hobby. The Bulletin Editor may succeed himself so long as the Club desires and he is willing to accept the responsibility.

Minutes, September 14, 2010

The September meeting of the CVGMC was called to order by club president Tom Winslow at 7:00 PM. Twenty two members were present and one visitor, Megan Russell of Hickory, was welcomed. Ken Twardzik was welcomed as a new member. The minutes of the August meeting were approved without corrections.

Treasurer's Report: Zan Ritchie stated the existing balance was \$12,538.29. He repeated the proper process of payment of dues which is covered in this month's newsletter.

Show Committee: Beth Oczkowski stated all of vendor contracts for next years' show have been mailed & three have been received back. George Max stated nothing new from the Convention Center.

Field Trip Report: Harry Polly informed the club that 12 members attended the Labor Day weekend hunt for geodes in Kentucky---the collecting was excellent.

Old Business: Beth Oczkowski hoped to have information next month from her daughter concerning a possible club web site. Harry Polly read a letter/e-mail from Mike Streeter concerning a club web site and his willingness to be the web master of the web site. Tom Winslow agreed to transfer the domain names CVGMC.com & CVGMC.org, which he's maintained, to the club.

New Business: Tom Winslow proposed a motion that a Lap Top be purchased by the club for:

- -club membership & data base
- -copy of website
- -maintain historical records

The Lap Top would reside with the treasurer--total expenditures may vary from several hundred dollars to \$1,000

After further discussion, Glenn Bolick made a motion which was seconded by Eric Fritz, that a board meeting should review this subject and present it's recommendation to the club at the next meeting--this was approved.

A Nominating Committee to be chaired by Harry Polly, will present a slate of officers to the club for 2011.

Door prizes were drawn by members. The program on Tumbling by Baxter Leonard was presented with his slant on success & failures.

The meeting adjourned with the conclusion of the program at approximately 8:20 PM.

Quarry in Marion. We will meet in






GRAVES MOUNTAIN FIELD TRIP OPPORTUNITY

WHAT IS A "PSEUDOMORPH"?

The mineral world is full of all sorts of surprises. Just because a mineral looks like one mineral doesn't mean that's what it is! Am I confusing you? There is a category of minerals that will confuse you. They are called pseudomorphs (pronounced soo-doe-morfs). Pseudomorph is from two Greek words that literally mean fake form. In the mineral world, a pseudomorph is a mineral that has the chemistry of one mineral but has the shape (that is, the crystal form) of another mineral.


This is what happens. A mineral forms in the earth. It slowly crystallizes until, at some time, the growth stops and the crystal is complete. Then, something changes in the earth. The chemistry around the mineral changes. This starts to change the chemistry of the crystal. Over time, thousands and thousands of years, the chemistry of the mineral changes.

HOWEVER . . . the crystal shape doesn't change! This creates a pseudomorph. The final mineral specimen has the chemistry of one mineral BUT the shape of another!!!! There are all sorts of different pseudomorphs. Here are some examples . .


